It's Time For Homeowners To Clean Up Fallen Limbs

The winter's snow and ice brought down many limbs around the neighborhood. Now that the warm weather has arrived, it's time for residents to get outside and remove all fallen debris around their yards.

Our HOA Restriction #15 states, "No owner of any lots in the Stonecrest Subdivision shall allow any grass or weeds to attain a height in excess of six (6) inches. Ornamental trees, shrubs and flowers shall not be included in this limitation. Dead trees must be removed from the lot within 6 months. Downed limbs and yard waste must be removed from the lot within 30 days. Composting of organic material is permissible. Open compost piles and compost containers/bins must be hidden from view. Compost containers/bins will meet all restrictions of City Ordinance Chapter 15, Article II, Section 15-27 (1) (a) as amended."

If you have fallen limbs, please take care of them immediately to keep our neighborhood looking good!

Here's Some Neighborhood Information You Should Know

SPEED LIMIT THROUGHOUT STONECREST - Please remember that the maximum allowable speed on any street in Stonecrest is 25 mph per city statute. Now that the warmer weather is here, many residents and children are outside walking. For everyone's safety, please drive carefully and observe the speed limit.

ATTENTION WALKERS, JOGGERS AND RUNNERS - Because we're concerned for everyone's safety throughout the neighborhood, please wear brightly-colored apparel when walking or running on Stonecrest streets. We want to make sure all drivers can see you!

FIREWORKS IN STONECREST - With July 4th not too far off, we want to remind all residents and their guests that ALL YEAR AROUND (not just on Independence Day), per city statute, most fireworks are prohibited in the city. The statute reads: No person shall store, offer for sale, expose for sale, sell at retail, use, explode, discharge, set off or possess any Class 1.4e, fireworks, devices or any device with a report: or any device that discharges a projectile or any firework orbidden for shipment by the Interstate Commerce Commission or any fireworks condemned or prohibited by the Bureau of Explosives, except for the following: a. Sparklers. b. Colored torches. c. Colored fire cones and boxes. d. Nonpoisonous snakes. e. Colored smoke items without report. f. Cones, fountains. g. Firwheels, spinners and spinners wheels. h. Snappers. i. Caps. as used in toy cap quiss. j. Confeit type popolers. i. Caps. as used in toy cap quiss. j. Confeit type popolers.

YARD WASTE AND LEAVES - Please note that it is a violation of St. Joseph city ordinances to blow or deposit leaves or other yard waste into a storm sewer opening. Failure to comply may result in a ticket and fine.

REPORTING A STREET POTHOLE OR DEFECT - Please remember that the Stonecrest Homes Association does not maintain the streets in our neighborhood. That's the responsibility of the City of St. Joseph. If you know of a pothole in your area, please report it to the city. Encourage your neighbors to do the same. Simply call the city at 816-271-4848. If you don't get results after 3-4 weeks, call again. Remember, oftentimes, the squeaky wheel qets the grease!

TREE LIMBS OVER STREETS & SIDEWALKS - Keep in mind that no tree in St. Joseph may have limbs or branches that hang over a city street or sidewalk any lower than 14 feet from the street/sidewalk surface. Property owners are responsible to trim and maintain their trees' branches so they are at least 14 feet above the surface of the street and/or sidewalk. If you have any questions or concerns. call the city at 816-271-4620.

REAL ESTATE SIGNS - Just as a reminder, it is okay to post a real estate "For Sale" sign in your own yard, but please refrain from posting real estate or directional signs in anyone else's yard or in our Stonecrest common areas.

RESTRICTION VIOLATIONS - Regarding potential violations of our homeowner restrictions, it is important to note that the board of directors does not police the neighborhood looking for violations. It is the homeowners' responsibility to report possible restriction violations to the board by filling out the Restriction Violations Form on our website (please use this form as opposed to calling the office or sending an email). Names of persons submitting reports are kept confidential and absolutely no anonymous reports will be addressed.

IMPORTANT NOTES ON PARKING ON STREETS - All Stonecrest residents should be familiar with St. Joseph City Code regarding on-street parking, in short, a vehicle may not be parked in one spot on any street in Stonecrest for a period of more than 48 hours. Here is the city code (part "b" applies to Stonecrest:

Sec. 28-664. Nighttime parking in central business district; parking more than 48 hours.

(a) Central business district. No person shall park a vehicle on any street in the central business district between the hours of 2:00 a.m. and 5:00 a.m. of any day.

(b) Outside central business district. No person shall park a vehicle on any street at any place outside the central business district for a period longer than 48 hours in succession. (Code 1969, § 21-238)

In addition, Sec. 28-638 says. Standing, parking to be parallel, close to curb. Except as otherwise provided in this article, it shall be unlawful for any person to stand or park a vehicle in a roadway other than parallel with the edge of the roadway headed in the direction of lawful traffic movement and other than with the wheels on the side of the vehicle nearest the edge of the roadway within 12 inches of the curb or edge of the roadway, and it shall not be parked closer than two feet from other parked vehicles.

And finally on parking and where you may park, please note that Sec. 28-661 states. Stopping, standing, parking prohibited in specified places. No person shall stop, stand or park a vehicle, except when necessary to avoid conflict with other traffic or in compliance with law or the directions of a police officer or traffic control device, in any of the following places:

- (1) No parking, official signs not required: a. Within six feet of a public or private driveway; b. Within ten feet of an alley; c. Within ten feet of a fire hydrant; d. Within 20 feet of a crosswalk at an intersection, except momentarily for the purpose of receiving or discharging persons, or goods, wares or merchandies; e. Within 50 feet of the nearest rail of a railroad crossing, if the crossing is marked in accordance with guidelines established in the Uniform Manual of Traffic Control Devices; f. Alongside or opposite any street excavation which would obstruct the free flow of traffic; and g. On the traveled portion of the roadway alongside any vehicle stopped or parked at the edge or cuth of a street.
- (2) No parking, official signs required. No person shall park at any place where official signs prohibit parking.
- (3) No stopping, standing or parking, official sign not required. a. On a sidewalk, b. Within an intersection: c. On an intersection crosswalk, whether marked or unmarked; d. On a clearly marked nonintersection crosswalk; a. Within 30 feet upon the approach to a flashing beacon, stop sign or traffic control signal located at the side of a roadway; f. Between a safety zone and the adjacent curb or within 30 feet of points on the curb immediately opposite the ends of a safety zone, unless a different length is indicated by signs or markings, in a lane used for or marked for the station; h. Upon any bridge or other elevated structure upon a street or within a street or highway tunnet, i. Except momentally for deposit or for an individual in the feet of any United States Postal Service mailbox used for the collection of mail; j. Except momentally for deposit or collection of mail; j. ITEMS NOT ALLOWED - yard waste in plastic bags, garbage/trash, bags weighing over 75 pounds each, railroad ties. NOTE: limbs/branches not bundled will not be picked up.

OFFICE UPDATE Reported By Jane Hausman, Secretary

DUES: Annual homes association dues collections for the June 2020/May 2021 year have almost ceased. Final letter requests for past due dues payments were mailed to the 18 past due property owners on January 9th, 2021. Liens were filed on 15 of these properties at the Buchanan County



County Court House on March 8th, 2021. (The lien filing charges to the property owners is \$54.00) If you have NOT paid dues for the 2020/2021 year, please contact or email the office.

E-MAIL ADDRESSES: Over 400 email addresses are now registered in our database for residential owners. All NEW residents moving into Stonecrest are asked to send their email address to the office by going to the website under "Contact Us". This allows the office to send out notices of meetings and events that affect you.

RESTRICTION VIOLATIONS: If a restriction violation is noticed by a resident, please fill out the Restrictions Violation Form on the website under Documents. Once a form has been filled out and sent to the office, the violation is investigated and then addressed personally with the resident. Most violations involve trailers & boats on driveways, yard maintenance, and general appearance of the property.

CONSTRUCTION APPROVAL FORMS: If you are planning on doing a construction project(s), you need to go to the website and fill out the Construction Approval Form (under Documents) PRIOR to starting your project. Once the form is received, the project will be taken under advisement by the Construction Approval Committee and you will be notified of the results.

NEW STONECREST PROPERTY OWNERS: Once transfer of property in Stonecrest is shown at the courthouse, the new homeowner is registered in our data base and the SHA office sends a packet to the new property owner. This packet includes a welcome letter, the most recent newsletter, and a copy of the HOA Restrictions. If you are new to Stonecrest and did not receive this packet, please call \(\textit{816-427-8663}\) or email \(\textit{office}\)\(\textit{office}\)\(\textit{office}\) and one will be sent.



So we're asking all Stonecrest residents to make a special effort to do something unexpected and kind for two or three of your neighbors on Saturday, April 17.


Of course, please practice the appropriate social distancing because we want everyone to be safe. But there's still plenty you can do to show your Stonecrest
